The reason for the proposed felling is that the client feels that the tree is too close to the main house. We did discuss an option to reduce, but as the tree has been lifted quite heavily in the past the options for reduction were more limited in terms of leaving a well-balanced tree.

In this notification there are 3 Norway Maples one of which is to be felled (for unstated reasons) yet as the tree are only identified by their species on the submitted plan it is not possible to identify which tree you are referring to as such please can you provide a plan that identifies which tree you are referring to in order that the notification can be validated.

It may be best to give each tree and its specification a number such as T1 then you will only need to annotate the location plan with the number rather than the whole name. There are also 2 Ceanothus with different specifications. Please can you send me the information ASAP so as to avoid delaying determination or the need to invalidate the notification.
