Ceonothus - reduce spread on house side by 2.5-3m. Reduce height by 2m and shape round Cherry - reduce spread on all sides by 1-1.5m to clear building and shape round Norway Maple - Reduce height by 2.5m. Reduce spread on all sides by up to 2m and shape round Norway Maple - reduce longest growths on all sides by up to 1.5m to shape imbalanced canopy Ceonothus - reduce height and spread on all sides by 1.5m and shape round
