Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Two Common Yew trees and one Monterey Cypress tree.
Currently these three trees are at the end of my garden and uprooting my fence which backs onto a public footpath and a road where cars pass to get to flats behind the house. I would like these 3 trees to be removed as they are causing a public hazard entering the path and increasing the risk to my property being exposed to the public. The Monterey Cypress tree is dying and breaking which is a further hazard to both my property and the public footpath behind the house.
I have been advised by a professional that in replace of these a Leylandi or Laurel hedge will be planted. They are not under a Tree Protection Order but are in a conservation area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
