- T1 Cedar: to remove the lower limb that has recently split out and lost half of the limb. The remaining limb has been compromised with a loss of approximately 50% of its circumference at the junction. There is concern that the remaining weight of the limb will cause the limb to fail, the tree is in busy public area. the proposal is to remove the limb back to the main stem. I have considered shortening the limb, however this will not reduce the major weight at the split junction without removing the foliage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
