Tree pruning in rear garden
A. Hawthorn tree - crown reduction by approx 2 meters B. Cherry Blossom tree. crown reduction and shaping. Minimal loss of height but spread to be reduced.
C. Pineapple bloom tree. Tree is about 2-3 meters high with a branch spread of about 2 meters. Hoping to prune back the spread only. Tree is
a little wobbly so will get advice about whether it is safe and can be supported. If not it may need to be removed. D. Overhanging trees and bushes from the old dairy site in Alexandra road. Not sure what they are but will prune back to the rear boundary
fence if my property
