All three trees below impinge on the roadway on Spring Lane, Shireoaks. We have consulted a tree surgeon and he recommends: Tree 1 - Large willow standing to the back of the site. Large branch extending over the road to be cut back approximately 4metres to the boundary and a second branch (lever arm) extending over the road supported by a hawthorn tree to be cut back by approximately 5 metres Tree 2 - Willow (bifurcating .6m above ground) branch extending over road to be cut back to boundary approximately 3 metres and another branch partially snapped extending over the river to be removed

Tree 3 - Stunted willow - main trunk truncated & remaining branch overhanging the road. The tree surgeon recommends that the tree is removed.

Reasons for removal, letter from Via Highways saying that overhanging trees encroaching on the highway

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
