Cherry (T1) Crown reduce by 3m in height and 1.5m laterally. Crown lift to 2.5m over the pavement and access to the property. Cherry (T2) Crown lift to 5m over the road and 2.5m over the pavement. Cherry (T3) Crown lift to 5m over the road and 2.5m over the pavement. Prune back branches on the south side of the tree by 1.5m to keep clear of the building. All works are required to provide adequate clearance from the highway and to ensure that the trees are maintained to a size suitable for the location and are clear of the building.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
