# Identification of Tree(s) and Description of Works

#### T1 Oak.

Tip reduce lateral branches overhanging the gardens of 3 and 4 Tottehale close by approximately 2.5m, the tree is in the neighbouring garden to the rear and the branches are covering a substantial amount of the clients back garden. The tree is also heavily unbalanced from what looks like an historic branch failure in the upper canopy breaking the lower branches on the neighbouring side on its way down, pruning would hopefully help the balance of the crown.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
