Due to the width of the lane, location of the south eastern access being on the bend of the road and proximity of neighbouring houses it is not possible for the timber frame to be delivered without the removal of most of the hedgerow along the boundary and extensive road closures. The applicant requests that the condition is amended to allow limited construction access via the existing entrance at the northern end of the site.	
The use of the northern entrance would allow a vehicle to be reversed from a straight section of the lane and exit the same way.	
The northern entrance would only be used where necessary and Tree Protection maintained at all times. A revised tree protection plan is attached.
