T1 - Removal of mature Dawn Redwood. The homeowner planted this tree approximately 30 years ago however, they are now regretting the position of the tree as after visiting a neighbours garden they have realised it is in close proximity to their garage and is also blocking a lot of light from the neighbours property. As these trees to not lend themselves to pruning, the homeowner would like to remove the tree with the idea of planting replacements in a more favourable position within the garden.

- T2 Sympathetic reduction of overhang from Red Oak. The homeowner also planted this tree approximately 30 years ago, and would now like to gently reduce it from the neighbours property side to allow more light into their garden whilst retaining a healthy well shaped tree of high amenity value.
