Ref Plan 1; Location of trees subject to works reducing height and then shaping. The numbers on the plan refer to the attached numbered photographs of the trees to be reduced.
Ref Photo 1; The Maple tree is close to the southern boundary of the property. It is proposed to reduce and shape the tree by approximately one third. There is an Elder tree growing through the mature box hedge which will be removed.
Ref Photo 2; This variegated Maple will be reduced in height by one third cutting away branches that are losing their variegation and then shaped.
Ref Photo 3; Minor shaping and trimming works are proposed for this Cherry tree.
Ref Photo 4; This Holly tree that is situated near on the southern boundary of the property is overgrown and will be reduced by up to half.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The trees are identified and numbered on the attached sketch plan. Trees numbered 3 & 4 are approximately 5m from a detached garage.

Tree 1 is a Maple and Ashorne Oak Tree and Garden services have advised that the crown should be reduced by approximately one third of the total height of the tree.

Tree 2 is a variegated Maple and the crown will be reduced by one third.

Tree 3 is a Cherry. The tree will reduced 1-2m from the crown and shaped.

Tree 4 is an overgrown and misshapen Holly. This tree will be reduced to the height of the telegraph pole which it surrounds.

Tree 5 is an old self setting Elder which will be removed. It is located within a mature box hedge and grows up through the hedge creating maintenance problems

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
