T1 - Horse Chestnut 3 meter reduction of over extended lateral limb which has recently become exposed due to limb failure in the lower crown. The limb is over extended and is carrying a lot of weight on the tip and due to its close proximity to the house i would like to reduce the limb by 3 meters to an adequate growth point which will prevent this limb from failing and also increase the appreance of the tree as it will look more balanced and symmetrical.

The tree is located in the rear garden of the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
