T1 Stunted Beech; to fell to ground level. T2 Larger duel stem Poplar; to fell to ground level. T3 Thin small Poplar; to fell to ground level.
Removing these trees leaves a nice example Beech and two semi mature Poplars which will fill the space left by T2.
G1 x3 Lime trees; to trim back the lower branches by upto 2.5m, no cuts higher than 6m. Also to cut back encroaching growth around the
