This is a mature Lime Tree which is historically and regularly pollarded. Over the past 25 years we have carried on with these works every 8 years or so from the previous owners. The old pollarding sprouts from a large high knuckle. The branches are now very wide in girth and very heavy and we are afraid they will break in the high winds and damage the house or highways and possibly passing pedestrians and cars. We would like to pollard this tree again as it is very top heavy as it's been many years since it was last carried out.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
