T1 - Poplar

Reduce length of all branches by up to 4 metres ensuring natural shape and balance typical of species is maintained where possible. Cut back overhang from Number 54, Rampling to boundary line. Prune to clear Fibre cable. Remove 2x lowest limbs and lift the remainder to approximately 4 metres. Sever lvy.

- · The tree is located in the car park area of Mascot Court located to the side of 54 Ramplings Close
- The tree is adjacent to the boundary wall of 54 Ramplings Close
- Reduction as part of a maintenance program to maintain the tree at a suitable and more desirable size fort its location
- To reduce the extent of the encroachment from 54 Ramplings Close
- To reduce the sail effect of the upper crown
- · To allow more suitable light levels in to the area

Left Hand Side of Property in Adjacent Car Park

T1 - Poplar

Fell to ground level and poison.
