Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1. Corylus avellana (hazel). Remove three upright stems beside gate post to improve light and maintain clearance from entrance. Various trees. Hawthorn, 2 x birch, 2 x hazel: prune trees to create a clear 700mm diameter clear path around telephone cable to minimise risk of cable breakage. Prunus laurocerasus (cherry laurel hedge). Reduce height to approximately 5m from road level and prune in sides as required (lapsed hedge – general maintenance). (Fence separately priced). Corylus avellana (hazel group). Coppice at 1m from ground level (including 1 x hawthorn) to form low hedge/screen, retain 2 x established field maples. If possible, split and lay hazel stems to fill gaps. Works to improve light. 6. Prunus laurocerasus (cherry laurel hedge). Reduce height to approximately 2m from ground level. Works to improve light. 7. Acer campestre (field maple). Remove all ivy and major deadwood. Works to improve light. Acer campestre (field maple). Remove dead parts of climbing rose which is in lower 8m from ground level of canopy. Works to improve light. 9. Carpinus/Acer (4 x hornbeam & 1 x Field maple). Coppice at ground level. Works to improve light. 10. Ulmus spp. (elm). Reduce dead elm to 5m monolith. 11. Ulmus spp. (elm). Reduce dead elm to 5m monolith. Fraxinus excelsior (ash). Fell stems down to 1m, leaving main base knuckle for habitat. Tree is infected with Ganoderma spp. and is unsafe. Prunus spinosa (2 x blackthorn). Fell to ground level to improve light. 14. Tilia cordata (lime). Re-coppice at 1m from ground level (back to main knuckle). Works to improve light.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
