Dear Tree Officer,

I purchased this house on 30th June 2023 and I checked with my solicitors before purchasing whether there is a TPO or not. It was confirmed to me by my solicitor that there is no TPO on any trees of this property. She did a local search and the tree did come under the search but it was also mentioned that no trees under TPO on this property.

My solicitor then raised this to confirm with the sellers solicitors to which they returned to advise the TPO did not relate to this property. The letter from the solicitor with the response from seller's solicitor confirming that the TPO HDC 1071-2001 does not belong to this property is attached with the application.

I requested my solicitor to check with seller solicitor based on the inputs from the tree officer on the phone and the seller solicitor told my solicitor that his conformation that this TPO does not belong to this property was based on seller's information. My solicitor mentioned to be that I will be able to pursue litigation for miss representation against the seller.

This was really important to me for this tree to be not under the TPO as I wanted to get this tree cut as otherwise I can not park my two cars in my driveway. The parking on the road is difficult as it is quite crowded. And I have to struggle every day to find a space to park my car.

The only car that I am able to park also gets dirty by the birds sitting on the tree, most times I have to park the other car on the road under the tree which again gets dirty.

I don't want to go to the route of filing the litigation case against the seller as I am hoping that my application would get a positive response from the council. I would be really grateful if you can allow this tree to be cut down.

## Identification of Tree(s) and Description of Works

The tree is a plum tree and is located in my front garden. The TPO reference is HDC 1071-2001.

I want to get the tree cut down with the stump removal to enable me to get some extra parking space to park both my cars

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
