Fell to ground level one fir tree (Leylandii) as marked in red on the sketch. The green line is the limit of the conservation area.
The tree was allowed to get to large during lockdown and we have been advised that it would be better to remove the tree than to try to reduce its size as the roots will start to undermine the garage and the neighbour's garden. This will also allow a lot more light into the garden of 5 Tudor Close, which should be the only neighbour affected by this.
