Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1. 1 x Large mature Ash tree rear garden right hand side. Crown re balance and shape as feasible / end weight reduce by approximate 1-2 meters or to suitable growth points. This is to keep the crown intact and reduce limbs from failing. 30% reduction or Pollard to T1. would cause more problems in future so we are aiming to minimise larger cuts and retain its structure.
- T2. Sycamore Rear garden left hand side. Re pollard and restructure to frame work. The tree has been very poorly pollarded so best and only option is to restructure beyond previous points then hopefully crown reduce in the future.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
