### Identification of Tree(s) and Description of Works

- This tree is a large single feature ash tree, Ref. No. 9/95/14 immediately adjacent to the B1054, in the extended garden of Rosemary Cottage that runs uphill from the house. I have been its keeper for 32 years. The minor works are:
- In the March 2022 storm a large branch broke off on the roadside. The stump needs trimming back
- A forked branch is resting on the telegraph wire
- Some minor dead wood pieces resting within the tree need removing
- On the garden side the lowest branch is now only 1.6m from the ground and needs lifting to 3m
- The arborists quote for these works is £200.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
