Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
The proposal is to fell two trees on the western boundary of the Spencer Holland recreation ground; a particularly sensitive location because of its use as a children's play area, although the trees in question are a little removed from the main focus of activities.
A clammy locust (T043) was identified as needing felling in the 2021 survey undertaken by John O'Conner because of a number of problems

including that it was touching the neighbouring property, had a compression fork, dead/missing bark on stem and damaged roots.

A goat willow (ref T042) was identified as needing felling in the 2023 report after a root raised the patio of the adjoining property and had to be removed causing instability in the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
