Babergh District Council as Local Planning Authority, hereby give notice that **LISTED BUILDING CONSENT HAS BEEN GRANTED** in accordance with the application particulars and plans listed in section A subject to the following conditions:

1. ACTION REQUIRED IN ACCORDANCE WITH A SPECIFIC TIMETABLE:
COMMENCEMENT TIME LIMIT

The works to which this consent relate must be begun not later than the expiration of three years beginning with the date of this consent.

Reason - To comply with the requirements of Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by Section 51 of the Planning and Compulsory Purchase Act 2004

2. APPROVED PLANS & DOCUMENTS

The development hereby permitted shall be carried out in accordance with the drawings/documents listed under Section A above and/or such other drawings/documents as may be approved by the Local Planning Authority in writing pursuant to other conditions of this permission or such drawings/documents as may subsequently be approved in writing by the Local Planning Authority as a non-material amendment following an application in that regard. Such development hereby permitted shall be carried out in accordance with any Phasing Plan approved under Section A, or as necessary in accordance with any successive Phasing Plan as may subsequently be approved in writing by the Local Planning Authority prior to the commencement of development pursuant to this condition.

Reason - For the avoidance of doubt and in the interests of proper phased planning of the development.

3. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: TIMBER
FRAMES

Prior to works to repair the timber frames, a detailed schedule of works for the repair or alteration including material specifications, and annotated photographs shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

4. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: LIME RENDER

Prior to the application of render (including any proposed finish), manufacturers literature including details of finish, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

5. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: FLOOR FINISHES

Prior to installation, manufacturers literature of internal floor finishes shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

6. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: MECHANICAL VENTILLATION

Prior to installation, manufacturers literature of the mechanical ventilation, including annotated photographs and/or plans of the proposed location(s) shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

8. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: FACING ROOFING MATERIALS

Prior to works above slab level, manufacturers literature of facing and roofing materials, including the altered roof slope, two small extensions, and the retaining brick wall, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

9. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: EAVES AND VERGES

Prior to works above slab level, large-scale elevation and section drawings of the eaves and verges for the new extension, and the altered roof slope, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

10. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: RAINWATER GOODS

Prior to installation, manufacturers literature of new rainwater goods shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

11. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: HARD SURFACING

Prior to installation, manufacturers literature of external hard surfacing shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

12. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: FENESTRATION

Prior to installation manufacturer's literature of new rooflights and sectional drawings showing them context within the roof slope shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

13. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: CHIMNEY

Prior to installation, manufacturers literature of any new chimney/cowl shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

14. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: FLUE

Prior to installation, manufacturers literature the flue, including its finish, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

15. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: TIMBER MULLION WINDOW

Following the removal of infill from the existing timber mullion window, and prior to the insertion of glazing, details of any works to remove, alter, replace or supplement sections of the existing timber, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

16. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: REPAIR WORKS

Prior to the commencement of repair works, a full schedule and specification of repair works to the building, including details of any materials, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

17. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: NEW FLOORING

Prior to the installation of the new first floor, section drawings showing the relation between the new floor and the ceiling, internal roof slope, and internal wall respectively shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

18. ACTION REQUIRED IN ACCORDANCE WITH SPECIFIC TIMETABLE: WALLS AND FLOOR BUILD UP

Notwithstanding the submitted details, section drawings for the walls to be re-rendered and for any floors to be altered, showing the proposed build-up of these elements including insulation details, shall be submitted to and approved in writing by the Local Planning Authority. The works shall then be implemented in their entirety in accordance with the approved details and retained thereafter for the lifetime of the development.

Reason: To protect the significance of the designated heritage assets.

1. **Statement of positive and proactive working in line with the National Planning Policy Framework (NPPF)**

The proposal has been assessed with regard to adopted development plan policies, the National Planning Policy Framework and all other material considerations. The NPPF encourages a positive and proactive approach to decision taking, delivery of sustainable development, achievement of high quality development and working proactively to secure developments that improve the economic, social and environmental conditions of the area. While the applicant did not take advantage of the service, the Council provides a pre-application advice service prior to the submission of any application. The opportunity to discuss a proposal prior to making an application allows potential issues to be raised and addressed pro-actively at an early stage, potentially allowing the Council to make a favourable determination for a greater proportion of applications than if no such service was available.

2. **Listed Building Note**

This listed building consent relates solely to the plans, drawings, notes and written details submitted with the application or as subsequently amended in writing and referred to in this notice. Any variation of the works or additional works found necessary before work starts or while work is in progress or required under the Building Regulations, or by the County Fire Services or environmental health legislation may only be carried out after approval by the Local Planning Authority. Unauthorised modifications, alterations or works not covered by this consent may constitute an offence under Section 9 of the Planning (Listed Buildings and Conservation Areas) Act 1990 and may render the applicant, owner(s), agent and /or contractors liable to enforcement action and/or prosecution.

Babergh and Mid Suffolk District Councils have adopted Community Infrastructure Levy (CIL) charging which affects planning permissions granted on or after 11th April 2016 and permitted development commenced on or after 11th April 2016. Important Notes to be read in conjunction with your Decision Notice

Please read carefully

This decision notice refers only to the decision made by the Local Planning Authority under the Town and Country Planning Acts and DOES NOT include any other consent or approval required under enactment, bylaw, order or regulation.

Please note: depending upon what conditions have been attached to the decision, action may be required on your part before you can begin your development. Planning conditions usually require that you write to the Local Planning Authority and obtain confirmation that you have discharged your obligations. You should read your decision notice in detail and make a note of the requirements placed on you by any conditions. **If you proceed with your development without complying with these conditions you may invalidate your permission and put your development at risk.**

Discharging your obligations under a condition:

You should formally apply to discharge your conditions and the relevant application forms are available on the Council's website. The Local Planning Authority has 8 weeks to write to you after you submit the details to discharge your conditions. You should always account for this time in your schedule as the Local Planning Authority cannot guarantee that conditions can be discharged quicker than this. A fee is applicable for the discharge of planning conditions.

Building Control:

You are reminded that the carrying out of building works requires approval under the Building Regulations in many cases as well as a grant of planning permission. If you are in doubt as to whether or not the work, the subject of this planning permission, requires such approval, then you are invited to contact the Building Control Section of Babergh and Mid Suffolk District Councils.

Appeals to the Secretary of State

1. If the applicant is aggrieved by the decision of the Local Planning Authority to refuse permission or consent, or to grant permission or consent subject to condition, they may appeal to the Secretary of State for Communities and Local Government. The applicant's right of appeal is in accordance with the appropriate statutory provisions which follow:

Planning Applications: Section 78 Town and Country Planning Act 1990

Listed Building Applications: Section 20 Planning (Listed Buildings and Conservation Areas) Act 1990

Advertisement Applications: Section 78 Town and Country Planning Act 1990
Regulation 15

Town and Country Planning (Control of Advertisements) Regulations 2007

Notice of appeal in the case of applications for advertisement consent must be served within eight weeks of receipt of this notice. Notice of Householder and Minor Commercial Appeals must be served within 12 weeks, in all other cases, notice of appeal must be served within six months of this notice. If this is a decision on a planning application relating to the same or substantially the same land and development as is already the subject of an enforcement notice, if you want to appeal against your local planning authority's decision on your application, then you must do so within 28 days of the date of this notice. If an enforcement notice is served relating to the same or substantially the same land and development as in your application and if you want to appeal against your local planning authority's decision on your application, then you must do so within: 28 days of the date of service of the enforcement notice, or within six months of the date of this notice, whichever period expires earlier.

The Secretary of State has power to allow a longer period for the giving of a notice of appeal but he/she will not normally be prepared to exercise this power unless there are special circumstances which excuse the delay in giving notice of appeal. The Secretary of State is not required to entertain an appeal if it appears to him/her that permission for the proposed development could not have been granted by the Local Planning Authority, or could not have been so granted otherwise than subject to the conditions imposed by it, having regard to the statutory requirements*, to the provisions of the Development Order, and to any directions given under the Order. The Secretary of State does not in practice refuse to entertain appeals solely because the decision of the Local Planning Authority was based on a direction given by him/her.

2. If permission or consent to develop land or carry out works is refused or granted subject to conditions, whether by the Local Planning Authority or by the Secretary of State and the owner of the land claims that the land has become incapable of reasonable beneficial use by the carrying out of any development or works which has been or would be permitted they may serve on the Council of the district in which the land is situated, a purchase notice requiring the Council to purchase his interest in the land in accordance with the provisions of Section 137 of the Town and Country Planning Act 1990 or Section 32 Planning (Listed Buildings and Conservation Areas) Act 1990.

*The statutory requirements are those set out in Section 79(6) of the Town and Country Planning Act 1990, namely Sections 70 and 72(1) of the Act.
