Oak tree on boundary of The Bumbles, Rohan and Tylers in Little Cornard. Due to branches overhanging our neighbours and also their proximity to the over-head power line adjacent to the tree, we are requesting permission to reduce back to its previous cut.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
