Field maple, No. 1 on plan.

Whole crown reduction of 2-3 meters.

Lift the canopy by about 3 meters (to the lowest branch).

We need to do this as the tree is overhanging both our house, the dividing fence and is nearly over our neighbours house at no. 4. The tree is only 0.5m from the fence and it's lower canopy is abutting the fence and our shed. We're worried that it is going to damage our roofs, the fence and the shed, if it is left.

The tree trunk is 2.5m from our house and about 3 meters from no. 4.

The canopy is very dense and is taking light from our lounge as well.

We have been advised by 3 different tree surgeons, and they all agree that work is necessary to maintain safety, give better light etc. We will be getting Kiwi Tree & Hedge Services to do the work once it has been agreed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
