Reports attached from Olivers' Tree Services from June 2016, February 2022 and October 2023 showing photos, decaying condition of T5, development of aggressive root fungus and most recent recommendation of its removal to ground level as T5 is dying and is dangerous to the adjacent road and overhead electrical wires.

Identification of Tree(s) and Description of Works

T5 (beech) tree has been recommended for removal to ground level by Olivers' Tree Surgeons.

This is due to the development of an aggressive root fungus at the base of the tree. As such, the tree is dying with minimal leaf coverage this year. All of the tree's weight is over Peareth Hall Road and the overhead electrical wires as well and as such, is dangerous in its present condition.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
