T1 - Silver Maple x12ms in height. Reduce height by 2ms and lateral growth all round by up to 3ms. Thin remaining crown by 10% leaving balanced crown.

T2 - Acer Crimson King x8ms in height. Reduce height by 2ms and laterals by up to 1.5ms to 2ms leaving shaped and balanced.

Work to be carried out due to shading out of plants in landscaped garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
