Ash Tree. This is an individual tree located and in front the garage between the houses of 2 and 3 Spion Kop, Claypit Lane, Thorner. The tree has had previous works carried out to it to lift the branches from the roof of the garage.

There are 2 lower limbs with the tips resting on the roof of the garage and these limbs need to be removed to reduce the incidence of damage to the roof.

Also dead wood throughout the crown to removed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
