We are a small building firm with property maintenance and gardening contracts at the above property.

The trees on the estate have not been shaped or pruned for approx 5 years and need doing this over winter.

12 white beams, 1 large callery pear and 6 wild cherry trees are on site plus other much smaller trees.

All trees require a winter prune and cut back. But due to the proximity to the buildings this needs to be substantial.

Further 4 of the wild cherry trees are only 8 feet from building lines and should not be there. They are also causing damage to doorways creating a very dangerous trip hazard. 4 of these wild cherries need removing. 2 immediately, 2 in due course.

(Photos submitted of the proximity to the buildings and the danger caused by the foot path)
