The Proposed works are as follows

Addition of dormer window to front elevation, Window will be constructed of solid oak joinery / Brickwork will be reclaimed brick to match existing and be pointed with lime mortar.

Addition of No 3 conservation velux roof windows.

Additional information / Background

After receiving pre application advice for this site we submitted a full application (22/02960/FUL) unfortunately by the time we received ecology representations it was too late into the Bat survey season for us to carry out the necessary amount of bat surveys that were required. At this point we faced having to wait for 7 months without being able to carry out any repairs/development of the property, the property was in a perilous state of dilapidation so this wasn't a good situation. Planning officer Kirsty Hodson made a suggestion that we could amend the scheme by removing any design elements that meant us disturbing the roof structure, negating the need for bat surveys and allowing us to commence remedial works during the period waiting for the bat survey season to recommence.

The suggestion made by Kirsty was that we had the Bat surveys done once the season for surveys recommenced and then for us to subsequently apply to amend the scheme by reverting back to the original design as seen in the attached elevations.

The original design was supported in principle by both planning and the conservation officer.
