T1: Eucalyptus. Reduce Eucalyptus in rear garden by 1-4m to create a slimmer, balanced crown. The tree is showing signs of stress, probably due to the drought last year. The majority of the reduction will occur on the lateral limbs that are over extended and prone to failure due to their length.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
