# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Oak tree in rear garden. Remove lower limb thats failed and hung in neighbours smaller tree. Crown lift lower limbs to balance after removal of damaged branch. Reduce crown by 3m to balance and shape. Tree is currently 20m tall with spread of 10m. Would reduce height to approx 16-17m and spread to 8m wide.

T2 - Sycamore tree, remove lower limbs starting to encroach on old walled boundary to give 2-3m clearance.

T3 - Willow tree, as above remove lower limbs starting to encroach on old walled boundary to give 2-3m clearance.

G4 - Group of small trees/hedging trees, blackthorn, hawthorn elder etc. Needs siding back to stop encroaching over the boundary area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
