The trees are growing in the neighbour's garden to the south west, at 19 Westgarth Avenue. The trees overshadow the garden of the applicant. There are damaged branches and dead wood in the Horse Chestnut which could cause damage if they were to fall on the applicant's garden. The owners were informed of the intended work on 4th August 2023, and have raised no objection.

Tree description: * Lime to the east of the Horse Chestnut. H 17m, S 11m, DBH 720mm. Dead wood at 6m and 10m.

Works description: * Reduce height by 2 to 2.5 metres and remove dead wood. Sever the Ivy at the base of the tree.

Tree description: * Hollies growing around the base of the Lime. Lapsed hedge. H3.5 - 4m, S 7m, DBH multi stem 15 -

Works description: * Reduce height of trees to around level with trellis at 2m. Trim the face back to the boundary line.
