T1 Holm Oak

Owners would like to re-pollard 2-3m lower than previous pollard points due to large area of decay on main trunk and Ganoderma bracket that was also increased in size of the last few years.

This would leave the crown with an approximate spread of 8-10 and a height of approximatly 10m

Reasons are to allow more light into garden and reduce the chances of failure.

T2 Holm Oak

Over hanging road has a v shape union at approximatly 1.5 heigh owners would like to reduce the weight over the road by reducing the lateral grown on roadside by 2m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
