- T1) Common Beech tree: Reduce radial spread over the office by approx 3m.
Reducing over extended growth to allow more light into office and reduce risk of failure onto building.
- T2) Turkey Oak: Reduce radially by up to 2m. Crown lift to 3.5m.
To allow grass maintenance by crown liting. Reduction to reduce over extended growth.
- T3) Turkey Oak: Remove deadwood and crown lift by 3.5m. To allow grass maintenance by cronw lifting.
- T4) Turkey Oak; Remove deadwood. Crown lift by 3.5m amd reduce radial spread over the shed and crown section over the drive by 2m.
Lifting over the lawn to allow grass maintenance. Radial reductions to reduce over extended growth.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
