T1) Common Beech tree: Reduce radial spread over the office by approx 3m.

Reducing over extended growth to allow more light into office and reduce risk of failure onto building.

T2) Turkey Oak: Reduce radially by up to 2m. Crown lift to 3.5m.

To allow grass maintenance by crown liting. Reduction to reduce over extended growth.

T3) Turkey Oak: Remove deadwood and crown lift by 3.5m. To allow grass maintenance by cronw lifting.

T4) Turkey Oak; Remove deadwood. Crown lift by3.5m amd reduce radial spread over the shed and crown section over the drive by 2m.

Lifting over the lawn to allow grass maintenance. Radial reductions to reduce over extended growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
