Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G1 Ash

There are 18 x Ash trees at the top of the bank which have extensive ash dieback.

Proposed works: fell the trees. This will ensure health and safety and prevent tree failure.

T2 Cedar:

Tree has a lot of deadwood situated at the top and very poor vitality in the crown.

Proposed works: Fell to ground level and remove all arisings

T3 Common Horse Chestnut:

Tree is in good health but has experienced a limb failure in recent weeks.

The tree requires maintenance and management to ensure long term safety and promote health.

It is located close to a structure and frequently utilised driveway.

The tree also has significant epicormic growth which needs management.

Proposed works: Remove epicormic to 8m, tidy the snag from snapped out branch, reduce the remainder of tree by 2m. SBTS will also inspect the crown whilst WAH to review and potential defects.

T4 Lime:

This lime tree has lots of epicormic growth.

Proposed works: Remove epicormic growth to 8m and remove arisings.

T5 Common Horse Chestnut:

This large common horse chestnut situated by the river bank has lots of epicormic growth.

Proposed works: Remove epicormic growth to 7m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
