Installation of Drainage and Soakaways and Replacement of Rainwater Goods.

There is an urgent need to install new below ground drainage. The current rainwater drainage is non existent except for the now defunct and ineffective French drains to the north and south aisles and chancel. Previous underground drainage was removed and not replaced in the mid 1960's. Consequently there is severe damp penetration under and within the church evident from the significant mould in the floor, walls and columns.

There is also an urgent need to replace existing asbestos downpipes and leaking gutters leading to new soakaways and to renew the French drains to prevent further deterioration.

Temporary measures have been made to take the roof water away from the foundations and air vents have been cleared.
