- T1 Sycamore Cut back overextended laterals over adjacent garden by approximately 2.5m as encroaching over boundary
- T2 Sycamore Cut back overextended laterals over adjacent garden by approximately 2.5m as encroaching over boundary
- T3 Maple Cut back to boundary fence line by reducing overextended laterals by approximately.5m
- G4 including Maples and Sycamore Cut back to boundary fence line as encroaching on adjacent gardens by approximately 1m. Crown lift over access road to 5.2m (T9-T21 and G5, G6 and N3 on TPO 31/92)
- T5 Multi Stem Sycamore Reduce in height by approximately 3m and cut back over extended laterals over car park
- T6 Multi Stem Sycamore Reduce in height by approximately 3m and cut back over extended laterals over car park
- T7 Ash, located in adjacent garden Cut back off building to give a 2m clearance
- T8 Sycamore Reduce in height by approximately 3m and cut back over extended laterals over car park
- T9 Sycamore Crown lift to 5.2m over access road
- T10 Sycamore Crown lift to 5.2m over access road
- T11 Sycamore Crown lift to 5.2m over access road
- T12 Sycamore Crown lift to 5.2m over access road
- T13 Sycamore Crown lift to 5.2m over access road
- T14 Ash Sever Ivy and cut back off building to give a 2m clearance

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
