Lime trees (T1-T3) - Reduce substantial timbers (those >~30cm diameter) of 3 Lime trees by a further ~4m, and reduce remaining timber by a further

~4m with the aim to produce a more rounded shape (rather than ovate) - This work will enable an improved view of the church for a longer period, on its

approach down church lane without significant detriment to the trees' visual amenity. This is very much of a repeat from previous years as there has been significant recent growth
