The co-ordinate stemmed Sycamore Tree is dying due to Black Soot Decease and it needs to be removed.

It appears that a stem has already been reduced heavily.

The TPO reference quoted WS312/A1 states - Several trees of whatever species.

We are unable to determine if this Sycamore Tree is included but suspect it is.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
