The panels are PHONOSOLAR 410w TWINPLUS X MODULE SERIES, each measuring 1722mm x 1134mm x 30mm and weighing 22kg, giving a total surface area of 3.44m x 7.94m. The project is part of the Hampshire County Council led Solar Together scheme, my reference being SPUK451048.
