## Identification of Tree(s) and Description of Works

The house we have is on the corner of Newbold Road & Newbold Back Lane and is a detached property. The house is set back from the front garden and is addressed as 1 School House Lane.

There is a large oak tree that as I understand when I bought the house (was newbuild from Miller Homes in 2019) is under a preservation order.

The tree is located in Newbold Back Lane just in front of our entrance to the back garden, a large proportion of the tree overhangs in our back garden area.

In the past 6 to 12 months the branches that overhang in our back garden area have grown substantially, branches are very close to the top bedroom window and other branches are very close to the roof.

I estimate that half of the tree branches overhang in our back garden, this obviously affects the light we get in the back garden. The tree at this time of year sheds leaves and many acorns as you can imagine as the tree is a large mature oak tree.

We kindly ask permission to reduce / remove the lower branches to a height (maybe to the start of the roof) that reduces the risk of branches hitting our house during high winds. This I expect will also allow more light into the garden.

We would invite you to visit so we can show you clearly from our back garden how the tree & branches are positioned and the need for the branches to be shortened.

We have a path that is paved and runs from the back gate (Newbold Back Lane) to the centre of the back garden, during the autumn period there is a higher risk of falling whilst walking on the path from back gate to centre of the back garden and entrance into the kitchen & patio.

The falling risk is with the leaves, acorns from the tree & wet floor from rain; I do clear the path but soon after the acorns & leaves return. I think by lifting the crown the amount of acorns & leaves will reduce and so reduce the risk of falling.

Hopefully you understand our concern and appreciate your permission in this matter.

PS - I am not so good on IT so the sketch may not be so good. I also do not know who owns the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
