### Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Tree 1: Scots Pine - Fell - Works are to allow more light into the borders below and more space for the surrounding mature trees.

Tree 2: Sweet Chestnut – Fell - The tree has little space to develop, its removal will allow more space for the surrounding trees in an overcrowded area of the garden.

Tree 4: Silver Birch (sapling) - Fell

Tree 5: Oak (sapling) - Fell

Tree 6: Scots Pine (Dead) - Fell

Works are to allow more light and space to the adjacent Katsura tree and prevent these saplings from potentially dominating the area.

Tree 7: Beech – Clear small diameter limbs from the BT line to establish a 50cm clearance of the line. Works are to prevent damage to the BT line.

Tree 8: Oak – Reduce limb extending towards the front right corner of the house by approximately 1.5m back to the primary branch. Leaving a retained branch length of approximately 7-8m. Works are to establish adequate clearance from the roof of the house.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
