We wish to place a root barrier next to the long tennis courts as indicated on the picture. The barrier will be 135metres in length, it will be situated outside the courts but as close to the fence as possible the barrier will be a control in the roots of the trees from damaging the surface of the tenis court, his will miotigate the risk of root egress which otherwise is a health and safety hazard for students playing tenis/netbal on these courts. The barrier will consist of Reroot 2000 Agrecultural root detering membrane.

The trees along this avenue are marked as the following numbers on the tree survey carried out bt the London Borough of Sutton: 3582 to 3620 (39 trees allgenus/species Tilia Euchlora)
