1x Ash - (G1) - Reduce overall canopies by 2-3 metres. Tulip Tree = (T2) - Reduce overall canopy by 2-3 metres.

Reason; Containment pruning of large tree species in close proximity to the highway and properties.

Cypress - (T3) - Fell.

Reason; This tree is in poor condition and substantially dying back.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
