T1 + T2 - Oak - Reduce lateral spread to clear the contact / encroachment onto properties. The reduction will be by 2 meters and the overall finishing spread will not be effected. Finishing limb lengths 4 meters. No height will be effected.

These works are proposed due to encroachment / contact to property
