# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Turkish Oak: This tree appears to be in decline. This tree has had deadwood removed periodically now resulting in the removal of major scaffold branches including the main leader with wound in excess of 300mm in diameter. This Oak is not putting out an inner crown as English Oaks do in their last stage of life with the majority of foliage present at the extremities, end weighting the branches. This tree has produced major deadwood throughout the canopy since its last pruning.

- Reduce in height by 8m.
  - o Changing the overall height from 20m to 12m.
- Reduce the eastern lateral quadrant by 3m.
   o Changing the radial spread from 8m to 5m.
- Reduce the southern lateral quadrant by 6.5m.
- o Changing the radial spread from 11.5m to 5m.
- Reduce the western quadrant by 6m.
- o Changing the radial spread from 12m to 6m.
- Reduce then northern quadrant by 5m.
  - o Changing the radial spread from 10m to 5m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\,$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
