T1 - Corsican Pine - Fell to near ground level

Reason - elevated risk of failure due to the following:

The tree leans significantly towards the neighbouring property, within impact distance of the upper 5m of crown;

- recent historic loss of large primary branch/co-dominant stem (400mm dia/600mm dia) at 4m and crown lifting creates notch stress on trunk;
- recent historic removal of adjacent group canopy (indicated by crown form with 2 x sycamore stumps approximately 300mm diameter adjacent) increases exposure to wind movement where previously sheltered and supported;
- recent soil disturbance and root damage from construction works and landscaping;
- reaction growth throughout the trunk indicates significant stresses being placed on the trunk;
- gap between the crown and adjacent canopy indicates possible movement of whole tree;

Replacement Planting: Corsican Pine

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
