We wish to make these changes following a fire strategy review of the building, whereby changes were made by advisement of building control to comply with fire-related building regulations. We also wish to make changes for structural reasons.

We would like to amend the approved plans with the following changes. Add an external door to the ground floor and a window to the first floor. This will be a fire escape door to the staircase and smoke opening vent window on the first floor for the corridor, both were added following a fire strategy review.
We would like to add two rooflight AOV's. These have been added to the stairwells for smoke ventilation in the event of a fire.
We would like to amend the look of the corner window. The corner window has been amended to two separate windows for structural reasons to allow a corner brick pier.
