T1 - mature sycamore (Acer pseudoplatanus) fell tree to ground level. The tree has outgrown its location and is now causing damage to the retaining wall that defines the garden boundary. the tree is dangerously close to the property and if it was to fail, it would cause significant damage to property and could be a threat to life.
